1 Name of Order

This Order is the Standard Instrument (Local Environmental Plans) Amendment (Miscellaneous) Order 2021.

2 Commencement

This Order—

- (a) commences on the day on which *State Environmental Planning Policy* (*Housing*) 2021, Chapter 3, Part 3 commences, and
- (b) is required to be published on the NSW legislation website.

[1] Clause 1.7 Maps [compulsory]

Omit "official NSW legislation website in connection with this Plan" from the note.

Insert instead "NSW Planning Portal".

[2] Land Use Table

Omit "State Environmental Planning Policy (Affordable Rental Housing) 2009 (including provision for secondary dwellings)" and "State Environmental Planning Policy (Housing for Seniors or People with a Disability) 2004" from the Land Use Table, note.

Insert instead "State Environmental Planning Policy (Housing) 2021".

[3] Land Use Table, Direction 5

Insert "Co-living housing;" and "Independent living units;" in alphabetical order.

[4] Land Use Table, Zone R2 Low Density Residential

Omit "Boarding houses;" from item 3.

[5] Clause 4.6 Exceptions to development standards [compulsory]

Insert after clause 4.6(8)(c)-

(caa) clause 5.5.

[6] Dictionary

Omit the definition of *boarding house*. Insert instead—

boarding house means a building that-

- (a) provides residents with a principal place of residence for at least 3 months, and
- (b) has shared facilities, such as a communal living room, bathroom, kitchen or laundry, and
- (c) has rooms, some or all of which may have private kitchen and bathroom facilities, and
- (d) is used to provide affordable housing,

but does not include backpackers' accommodation, co-living housing, a group home, hotel or motel accommodation, seniors housing or a serviced apartment.

[7] Dictionary

Insert in alphabetical order—

co-living housing means a building or place that-

- (a) has at least 6 private rooms, some or all of which may have private kitchen and bathroom facilities, and
- (b) provides occupants with a principal place of residence for at least 3 months, and
- (c) has shared facilities, such as a communal living room, bathroom, kitchen or laundry, maintained by a managing agent, who provides management services 24 hours a day,

but does not include backpackers' accommodation, a boarding house, a group home, hotel or motel accommodation, seniors housing or a serviced apartment. **Note—** Co-living housing is a type of *residential accommodation*—see the definition of that term in this Dictionary.

independent living unit means a dwelling or part of a building, whether or not attached to another dwelling—

- (a) housing seniors or people with a disability, and
- (b) containing private facilities for cooking, sleeping and bathing, and
- (c) where clothes washing facilities or other facilities for use in connection with the dwelling or part of a building may be provided on a shared basis,

but does not include a hostel.

Note— Independent living units are a type of *seniors housing*—see the definition of that term in this Dictionary.

[8] Dictionary, definitions of "group home (permanent)" and "group home (transitional)"

Omit "State Environmental Planning Policy (Housing for Seniors or People with a Disability) 2004" wherever occurring.

Insert instead "State Environmental Planning Policy (Housing) 2021, Chapter 3, Part 5".

[9] Dictionary, definition of "registered community housing provider"

Insert in alphabetical order-

registered community housing provider has the same meaning as in the *Community Housing Providers (Adoption of National Law) Act 2012*, section 13.

[10] Dictionary, definition of "residential accommodation"

Insert after paragraph (b)—

(baa) co-living housing,

[11] Dictionary, definition of "residential accommodation" Insert after paragraph (f)—

(faa) independent living units,

[12] Dictionary, definition of "residential flat building"

Insert ", co-living housing" after "attached dwelling".

- [13] Dictionary, definition of "secondary dwelling", note Omit "clause 5.4". Insert instead "clauses 5.4 and 5.5".
- [14] Dictionary, definition of "seniors housing", paragraph (b) Omit the paragraph. Insert instead—
 - (b) a hostel within the meaning of *State Environmental Planning Policy* (*Housing*) 2021, Part 5, or
