#### 1. Name

This Instrument is the Environmental Planning and Assessment Act 1979 Instrument of Delegation for Functions under the Act and the Environmental Planning and Assessment Regulation 2021 (Planning Secretary) June 2024.

### 2. Commencement

This Instrument commences on the day on which it is signed.

# 3. Interpretation

1. In this Instrument:

Act means the Environmental Planning and Assessment Act 1979.

**Planning Secretary** means the Secretary of the Department of Planning, Housing and Infrastructure.

Regulation means the Environmental Planning and Assessment Regulation 2021.

- 2. Unless otherwise defined in this Instrument, words and expressions that are defined in the Act and the Regulation have the same meaning in this Instrument.
- 3. Unless otherwise specified, a reference to an Act includes a reference to the Act as it exists from time to time and any regulations or instruments under that Act.

# 4. Delegation of functions
